Information about us

Wildlife Conservation Research Unit (“**WildCRU**”) is a research unit based within the Department of Zoology at the University of Oxford (“**University**”). WildCRU is situated at Wildlife Conservation Research Unit, Department of Zoology, University of Oxford, Recanati-Kaplan Centre, Tubney House, Abingdon Road, Tubney, Oxfordshire, OX13 5QL.

Information we may collect from you

No personal data is collected by this site.

With regard to each of your visits to the site we may automatically collect the following non-personally identifiable statistical and technical information:

- about your computer or other device used to access the site, including the internet protocol (IP) address used to connect to the internet, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from the site (including date and time), pages you viewed or searched for, page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.

The technical information we collect from you is statistical data about our users’ access to the site, browsing actions and patterns which does not identify any individual and allows us to ensure that content from the site is presented in the most effective manner for you and your computer or other device.
